Dear Planning Commission Members,

The Mid Atlantic Soybean Association is in full support of the rezoning request for Mountaire Farms of Delaware, Inc./Z 2003 KAR Farming Company, LLC.

Agricultural crop production in the Mid Atlantic States is dominated by the production of soybeans, corn and other feed grains. The Delmarva poultry companies are the primary purchasers of this production. In 2021 they purchased \$1.3 billion of soybeans, grain and other feed ingredients. There are nearly 1,400 farm families that contract to raise poultry on Delmarva and nearly 18,000 employees that work directly for the Delmarva poultry companies. The wholesale value of Delmarva poultry production in 2021 was \$4.2 billion.

While these numbers should be significant on their own, we would also point out the number of small businesses and workers that provide inputs and support services to the grain farmers, poultry farmers and poultry companies. A University of Delaware economic analysis confirmed that every dollar of direct revenue received by a Delaware farmer creates an additional \$8 or more of economic activity in our local communities. Agriculture is the largest economic driver to Sussex County and the State of Delaware.

Agriculture is also the least expensive type of economic activity for government entities to provide services to. This County and State has been blessed for centuries by the inspirational work ethic and dedication to community that is exhibited by the agrarian lifestyle and traditional values of its farmers. We contend that it should be very desirable to assure that agriculture may remain a viable pursuit for Sussex County residents. The greater the ability of our agricultural land to provide for our families, educate our children, support our community institutions, provide for our retirements and senior care, without expecting or needing support from government – the stronger our social fabric. And the less enticing that it is for the agricultural land to be converted to other uses that require greater services to be provided by government entities.
